Should a loss occur prior to such agreement being obtained cover may be provided but only if cover would have been available at a reasonable commercial market rate on reasonable commercial market terms.</p> <p>Where storage and/or other static exposures are also covered by the Insurance, this clause shall also apply to covered risks from the time the relevant geographical area changes in the GCWL. The applicable GCWL designated category for any particular transit/risk shall be that which is in force at the time transit/risk commences.</p>
